Indian Institute of Forest Management, Bhopal, a premier sectoral Management Institute an autonomous Institute under Ministry of Environment, Forest and Climate Change, Government of India, invites applications Fellow Programme in Management (2019-2023) commencing from July 2019.

Areas of Specialization

(1) Communication and Extension Management (2) Ecosystem and Environment Management (3) Environment and Developmental Economics (4) Financial Management (5) Human Resource Management (6) Information Technology and Quantitative Techniques (7) Marketing Management (8) Sociology and Community Development (9) Technical Forestry (10) Strategic Management.

Eligibility

Maximum age limit is 45 years as on 1st July 2019. A Bachelors degree with at least 50 percent marks and Masters degree (minimum two years prescribed duration after 10+2+3 years of formal education) in relevant discipline (relevancy has to be decided by the IIFM) with minimum first class including Five year/Four-year Integrated Master's Degree programme and with good academic records., or Professional qualification like CA, ICWA, CS with minimum 55% marks (absolute) or for IIFM Graduates, who have done PGDFM and IIM graduates who have done PGDM, the minimum OGPA of 3.00 in 4.33 maximum scale, is required or For MRM Post Graduates from IIFM, with 3.00 CGPA.

Note: For those qualifications where the above 4.33 scale is not available, the eligibility will be decided by the Equivalence Committee constituted by the Director, IIFM and its decision will be final.

Admission Screening Tests

Eligible candidates with CAT/GMAT scores not more than two years (minimum cut off will be decided by IIFM) or UGC-CSIR-JRF/NET or GATE or ICAR NET examination (not older than 5 years) or candidates who have obtained a PGDFM/PGDM from IIFM/ IIM with a minimum OGPA of 3.00 in 4.33 maximum scale or MRM Post Graduates from IIFM, with 3.00 CGPA or qualified FRI entrance test for Ph.D (two years old) or All India and allied services officers, officers in scale-II of Nationalized Banks & officers of equivalent rank of PSUs can apply directly. Candidates who fulfill the required eligibility criteria as above and do not have any of the above qualifying test scores, but have five years' experience (post their respective eligible degree) shall be called for the internal test and those who qualify in the internal test will be called for Presentation and Personal Interview.

Note: For those qualifications where the above 4.33 scale is not available, the eligibility will be decided by the Equivalence Committee constituted by the Director, IIFM and its decision shall be final.

Presentation & Interview

Shortlisted candidates will be required to make a brief presentation on a research topic of their interest followed by interview. The written test will be held at IIFM, Bhopal on 11th June, 2019 followed by presentation and interview for shortlisted candidates.

Financial Assistance

Each student would be given a monthly fellowship of Rs.16,000/- in first and second year; Rs.19,000/- in third and fourth year during the programme. A contingency grant of Rs.35,000/- per year would also be provided.

How to Apply

Interested candidates are required to submit their application in the prescribed application form with all supporting documents mentioned in the form.
