A. Background

India has adopted the principles of sustainable forest management and developed the National Set of 8 Criteria and 37 Indicators on Sustainable Forest Management from the Bhopal – India Process. The Bhopal-India Process is one of the 9 internationally accepted frameworks¹ for the Criteria and Indicators (C&I) approach to sustainable forest management. These C&I were incorporated into the National Working Plan Code (NWPC) 2023 in the form of the Indian Forest Management Standard (IFMS). This subsequently led to the formation of the IFWCS, which was launched by the Ministry of Environment, Forest and Climate Change (MoEF&CC), Government of India. Therefore, the certification of the forest areas (forest divisions or plantations) and Trees Outside Forests (TOF) using standards adopted by the IFWCS is at par with the internationally recognized certification system, while being relevant in the Indian context.

The European Union (EU) Regulation on Deforestation-free Products (EUDR) 2023/1115 requires operators and traders placing specific commodities and derived products on the EU market or exporting them to demonstrate that these products did not originate from recently deforested land or contribute to forest degradation, repealing the EU Timber Regulation (EUTR) with specific transitional provisions.

The Harmonized System (HS) code, developed and administered by the World Customs Organization (WCO), is a major international standard for classifying traded goods, and was implemented in 1988. This empirical system organizes commodities into categories based on economic activity, encompassing 21 sections, 99 chapters, 1,244 headings, and 5,224 subheadings. The HS codes facilitate universal classification of product, enabling efficient customs processing, accurate tariff application, and comprehensive trade statistics, which are essential for global commerce.

By organizing products into different classes, HS codes enable governments, businesses, and organizations to communicate effectively about goods, ensure compliance with regulations and facilitate trade negotiations. Furthermore, they aid in tracking trade flows and enforcing trade policies, making them essential for economic analysis and policy formulation.

B. Introduction

The Indian Forest and Wood Certification Scheme (IFWCS), branded as “**PRAMAAN**” (Program for Recognition and Accreditation of Sustainable Management Practices for Agroforestry and Natural Forestry Resources), is a national initiative to promote sustainable management of forests and Trees Outside Forests, and responsible production and harvesting of wood and non-wood forest-based products through a voluntary third-party assessment process. Through the certifications of Forest Management (FM), Trees Outside Forest (TOF) Management, and Chain of Custody (CoC), the IFWCS provides market incentives to various Forest and TOF managers, and forest-based industries that adopt sustainable practices in their operations and comply effectively with the requirements of the IFWCS standards. These include State Forest Departments, individual farmers,

or farmer producer organizations engaged in agroforestry and on-farm forestry, and other wood-based industries in the value chain of forestry products.

This document outlines the classification of wood and non-wood-based forest products relevant to the scope of certifications under the IFWCS, using the Harmonized System (HS) Codes, a standardized international system for categorizing commodities and facilitating international trade, thereby ensures consistency and clarity in the certification scope under IFWCS.

The product groups provided in this document have been sourced from the ITC (HS) based Export Policy issued in India by the Directorate General of Foreign Trade (DGFT), Ministry of Commerce & Industry, Government of India. This information is intended for reference purposes and may be subject to updates or changes by the relevant authorities.

C. Mission of the scheme

The promotion of sustainable management of forests and TOF and the provision of market incentives for the forest managers and forest-based industries that comply effectively with the requirements under IFWCS standards.

D. Scope

To ensure consistency and clarity in the certification process, this document provides the classification of wood and non-wood products relevant to the scope of following certifications under the IFWCS using the Harmonized System (HS) codes:

- Forest Management Certification
- Trees Outside Forests (Management) Certification
- Chain of Custody Certification

All aspects of this standard are considered to be normative, including the scope, standard effective date, references, terms and definitions, notes, tables and annexes, unless otherwise stated.

Goods as classified in the EUDR regulation², and falling within the scope of the IFWCS are listed in Annex I (Relevant commodities and relevant products under EUDR) of this document. EUDR products listed in the Annex I are also cross-referenced in the relevant sections of the [list of products applicable under the IFWCS certifications](#), set out in this document.

This document will be updated at regular intervals in order to reflect the increasing range of certified products covered under the IFWCS.

E. How to Use the List of Applicable Products under IFWCS Certification

This document outlines the classification of relevant wood and non-wood products from forests and TOFs relevant for certification under the IFWCS, using Harmonised System (HS) codes to ensure clarity and consistency in the certification process.

As published in the Indian Trade Classification (Harmonized System) based Export Policy by the DGFT, in an eight-digit HS code, the first two digits represent the chapter, followed by two digits for the heading, two digits for the subheading, and another two digits developed in India under the common classification system for the item.

As detailed in the, the meanings of Chapter, Heading, Sub-heading and Items are as under:

- "Chapter"**, in respect of goods, means a description in this list accompanied by a two-digit number and includes all headings of items the first 2 digits of which correspond to that number.
- "Heading"**, in respect of goods, means a description in this list accompanied by a four-digit number and includes all sub-headings of items the first four digits of which correspond to that number.
- "Sub-heading"**, in respect of goods, means a description in the list of this Schedule accompanied by a six-digit number and includes all items the first six-digits of which correspond to that number.
- "Item Description"** means a description of goods in the list of this Schedule accompanying eight-digit HS Code as given in the Column 4.

This policy is divided into twenty-one primary sections, each detailing unique product groups categorised into 98 chapters. The chapters falling under each section of products are elucidated in the list given below:

NOTE: The EU Deforestation Regulation (EU) 2023/1115 mandates that any operator or trader who places these commodities on the EU market, or exports from it, must be able to prove that the products comply with local laws, and do not originate from recently deforested land or have contributed to forest degradation. This regulation covers commodities such as cattle, cocoa, coffee, palm oil, rubber, and wood, along with their derived products. It replaces the EU Timber Regulation with specific transitional provisions. Goods as classified in the EUDR, and falling within the scope of IFWCS, are listed in Annex I of this document and are also cross-referenced within the relevant sections of the list of products applicable to the certifications under the IFWCS.
