It involves identifying and measuring various benefits and costs of the environmental goods and services, putting value tags on them, and recording them in appropriate sets of accounts/statements. It comprises both physical accounts and monetary accounts. The need to account for the environment and the economy in an integrated way arises because of the crucial role of the environment in economic performance and in promoting human welfare.
